The Two Sides of the House of the Community Foundation

Thanks to generous donors like you, the Community Foundation is a leader in grant and scholarship funding and has given back more than \$64 million to the community since 1986. We are a nonprofit, community corporation created by and for the people of Frederick County. We are here to help businesses, individuals, families, and other civic causes do good work ... forever.

You might have a general idea of what the Community Foundation does and what our mission is, but have you ever thought about how we make all that great work happen?

Community foundations generally have three distinct features: they create permanent endowments; they have broad, flexible purposes and monitor community needs; and they provide opportunities for personalized giving.

The Community Foundation of Frederick County is comprised of "two sides of the house." Our Philanthropic Services Department is responsible for all the money that comes into our organization. Philanthropic Services staff work with donors to fulfill their charitable intents and build permanent funds that grow and benefit our community forever. They help donors create an individual or family legacy, and they offer donor involvement in selecting nonprofits and criteria for scholars who will benefit from their funds.

Central to the Philanthropic Services team's work now is the Forever Frederick County campaign, which is creating funds to provide strategic grants based on Frederick County's most pressing needs as determined by the 2018 Human Needs Assessment and similar studies going forward. To date, almost \$14 million has been raised, which is \$6 million from the campaign's goal.

Our Community Impact Department is responsible for all the money that goes out of our organization. Community Impact staff manage our grantmaking program, which supports a wide variety of community interests and causes with one goal in mind: improving the quality of life in Frederick County. Our grant funding is divided into strategic grants, impact grants, rolling grants, and donor-advised and designated grants.


Strategic grants fund nonprofits that provide programs addressing the areas of greatest need in Frederick County, which have been identified in our 2011 and

2018 Human Needs Assessment reports. Impact grants support a wide array of programs that improve the community and provide opportunities for people of all ages. Funding can support many areas including the arts, youth programs, health and human services, and historic preservation. Rolling grants support nonprofits that meet the needs of individual Frederick County residents as well as a wide range of field of interest and special purpose funds. In FY19, the total of all grants (strategic, impact, donor-advised, and designated) was \$5 million. That's a lot of impact in Frederick County.

Our Community Impact team also oversees our scholarship program, which supports nearly every area of study imaginable, with scholarships funded by generous donors who believe in the value of education. For the 2020–2021 academic year and for the fifth consecutive year, more than \$1 million will be provided to deserving students.

Community Impact staff are now busy with scholarship season. The team spent the month of February at high schools throughout Frederick County letting students know about the variety of scholarships available. Now they are preparing scholarship committee volunteers to receive and review, at minimum, 1,200 applications.

This is just a small glimpse into the world of what we do "in our house" here at the Community Foundation to translate simple good intentions into powerful acts of philanthropy that build a stronger, more vibrant community not only for today but for the future.

- 1 A grant from The Boy Scouting in Frederick County Region Fund supported local scouting activities in Frederick County, such as hiking and swimming.
- 2 Residents in the Willows Memory Care Unit at Homewood at Crumland Farms participate in music therapy sessions in groups or individually, helping to improve their physical, emotional, and communicative responses. The program is supported with a grant from The Geraldine Virts and Jack Brady Memorial Fund for Alzheimer's Disease and Related Disorders.
- **3** A young man rides Tucker, one of the therapy horses at Frederick County 4-H Therapeutic Riding Program. Participants in the program who have mental, physical, and/or emotional disabilities learn basic horsemanship skills, which help them attain better physical and emotional skills. The program was supported with a grant from The Frederick County 4-H Therapeutic Riding Program Fund.
- 4 Heritage Frederick received two grants in support of garden projects. A grant from The Mary Gregg Cornish Memorial Fund supported educational programming in two new garden spaces: Story Time Garden and Medicinal Garden. A grant from The Don Doughty and Linda Moran Fund supported garden and streetscape improvements for its Church Street property.
- 5 A grant from The Mark and Susan Butt Saturday Mornings Fund provided more than 450 foster families with toys, gift cards, holiday items, and other necessities for children and youth in foster care, seniors, and vulnerable adults during the recent holiday season.
- **6** The first grant from **The Claire McCardell Project** Fund, established by The Frederick Art Club, is supporting the creation of a statue honoring the iconic fashion designer, Claire McCardell. The statue will be installed in 2021 at the east end of Carroll Creek Linear Park in Frederick.























- **7** Frederick Health (formerly Frederick Memorial) Hospital partnered with Frederick County Department of Social Services to expand in-home services to seniors age 65+, including medication adherence and support. With medication review, reminders, and organization, more seniors in Frederick County took their medications on the correct schedule resulting in fewer adverse drug interactions and visits to the hospital's emergency department. A grant from The Health Care Strategic **Initiatives Fund** supported the project.
- 8 The grounds at Hood College received its annual grant support from The Helen G. and Alfred G. Zimmerman Hood College Ground Beautification Fund, helping to enhance time on campus for students and visitors.
- **9** In 2012. Graceham Moravian Church created its Served with Grace ministry, a free meal on the first Monday of each month. Supported with a grant from The Graceham Moravian Church Fund, an average of 110 people participated each Monday.
- **10** Habitat for Humanity of Frederick County, Maryland, through its A Brush With Kindness Program, received a grant from The William E. Barnhart Memorial Fund to help two elderly sisters with a much needed roof replacement. Both are fighting cancer, and this assistance allowed them to stay in their home.
- 11 The Animal Welfare League of Frederick County coordinates foster parents to bottle feed kittens whose mothers cannot be found. Once old enough, they are spayed/neutered, microchipped and vaccinated, and then are available for adoption. A grant from The Nathan G. McDaniel Fund for The Animal Welfare League of Frederick County supported this program as the kittens awaited their forever homes.
