Volunteers Play Vital Role in Community Foundation's Work

If you know the Community Foundation, you know that we are doing important work all across Frederick County. Last year alone, we distributed \$2.2 million to more than 330 scholars and infused \$6.3 million into the community through grants to nonprofits. But what many people might not realize is how ingrained volunteers are in the work we do every day.

The Community Foundation relies on a board of 25 trustees to steer the organization towards a sustainable future through sound, ethical and legal governance and financial management policies. Last year our trustees worked tirelessly with consultants and staff to build a new strategic plan that will help guide the organization through the next decade.

We also rely on hundreds of volunteer committee members that support varied programs and initiatives like the Audit Committee, Development Committee, Governance Committee and Investment Committee, to name a few.

Veronica Lowe joined the Community Foundation as a trustee in 2019. She is one of more than 200 trustees that have helped build and steer the Community Foundation since its founding in 1986.

"I think volunteer opportunities shaped me when I was younger," Lowe said.

Lowe, who is the deputy director of labor relations for the Maryland Department of Transportation, explained that she finds her work with the Community Foundation to be really rewarding, especially working on the Grants Committee.

"It's a lot of work, but I walk away every time feeling really good about what we're doing for the community, especially during COVID when all the money came in to help organizations," Lowe said. "You just feel good that you're giving your time to help other people."

The Community Foundation's largest volunteer committee, the Scholarship Committee, relies on the efforts of about 75 individuals who give upwards of 20 hours in the spring to review more than 1,000 scholarship applications. The demanding work ensures that each application is reviewed with care and diligence in a process that includes

donor participation and compliance with the IRS. The Grants Committee has fewer volunteers but also has a great impact, giving countless hours to review grant applications. These volunteers make difficult decisions knowing the need always exceeds the amount of funding available.

Dick and Sue Basford have both had their feet solidly planted in Frederick County for their entire lives. According to Dick, they were both farm kids, "for both of us, our heritage goes way back in Frederick County – back to the 1800s." Sue added that they both "quit the ag life" after high school. Dick went on to become the Funeral Director at Keeney and Basford Funeral Home where he worked for 44 years, and Sue's career was spent in the classroom as a teacher.

Between careers and raising three children, the Basfords had their hands full. But community service was always important to them. Dick learned firsthand the importance of volunteers at the Community Foundation in the early 1990s when he served as one of our trustees. Both Dick and Sue have served on the grant and scholarship committees on and off for nearly two decades.

It goes without saying that volunteers are invaluable in supporting and guiding the Community Foundation.

Volunteers bring a range of diverse voices and lived experiences to the table, critical to making smart and informed decisions about the important work we do throughout the community. Additionally, having engaged citizens involved in determining how and where our grant and scholarship dollars are spent adds a layer of transparency to our processes.

WERTHEIMER NOMINATIONS WILL BE ACCEPTED IN MAY

The Wertheimer Fellows for Excellence in Volunteerism Award honors the legacy of the late Janis Miller Wertheimer, a well-known Frederick businesswoman and prolific volunteer. The awards program is made possible through The Janis Miller Wertheimer Endowment Fund. Since it was started in 2003, more than 61 individuals have been celebrated for their commitment to community service.

Anyone can make a nomination and only individuals who are at least 18 years old are eligible for the award. The award is not for couples, groups, clubs or organizations.

The Wertheimer Youth in Action Award, now in its 12th year, recognizes youth under the age of 18 who are positively impacting the community by volunteering their talents and energies in extraordinary ways.

The Community Foundation Frederick County will accept nominations for the 2023 Wertheimer Fellow for Excellence in Volunteerism and Youth in Action Awards from May 1 through May 31, 2023 via our website at FrederickCountyGives. org. Late entries will not be accepted, and nominations can only be submitted online.

The honorees will be recognized at the Community Foundation's Annual Report to the Community in November 2023. Wertheimer Fellows are awarded \$25,000 to establish or add to a permanent fund with the Community Foundation for the nonprofit or charitable endeavor of their choice. The Wertheimer Youth in Action honoree will receive a \$2,000 grant to support a Frederick County nonprofit organization of their choice.





Thanks to the support of donors, last year the Community Foundation distributed \$6.3 million in grants to hundreds of nonprofits serving in the areas of health and human services, youth programs, historic preservation, basic human needs, the arts, elder care, animal well-being, the environment and so much more.



February Star Sanctuary rehabilitates and provides a permanent refuge for cats and horses who have been abused or abandoned. Part of the sanctuary's mission is to build a generation of animal advocates by teaching children compassion toward the animals. Grants from THE ROBERT AND CAROL SHARPE FUND, THE NONPROFIT SUPPORT FIELD OF INTEREST FUND, THE FELINE WELFARE FUND, and THE ANIMAL CARE FIELD OF INTEREST FUND supported this nonprofit.



The Maryland Food Bank received an **UNRESTRICTED GRANT** which was used to support the Brunswick food bank. This is a vital program for elderly residents in Brunswick, as food costs have become a challenge for the senior population, who are very appreciative of the opportunity to save money and receive nourishment.



The Literacy Council of Frederick County's Parent Literacy Program focuses on improving the communication skills of parents of young children in Title I elementary schools in Frederick County. These parents worked diligently to receive their completion certificate and goal of leading their families to success.
